

**GLACIER PEAK YOUTH FOOTBALL ASSOCIATION ("GPYFA")  
GENERAL RELEASE AND ASSUMPTION OF RISK FOR PLAYER USING  
NON-ISSUED GPYFA FOOTBALL EQUIPMENT**

In consideration of the Glacier Peak Youth Football Association, a Washington nonprofit corporation, ("GPYFA") permitting my child for whom I am a parent or guardian ("Minor Child") to participate as a player in the GPYFA and utilize equipment that may include a football helmet, shoulder pads or football pants, or related accessories that has been supplied by me at my request as the parent or guardian and not issued by the GPYFA for my child's use during the season, I agree to forever release, indemnify and discharge GPYFA, including its successors, predecessors and assigns, on its own behalf and on behalf of each and all of its parent, related, affiliated, controlled or subsidiary organizations, and each and all of its respective board directors, officers, agents, attorneys, representatives, coaches and volunteers, past, present and future on behalf of myself, my spouse, my children, my parents, my guardians, and my heirs, assigns, personal representative and estate, and any and all other persons and entities who could in any way represent me, the Minor Child or act on our respective behalves, from any claims, causes of **action, suits, debts, damages, judgments, and claims and demands whatsoever, in law or in equity** for personal injury, disability, property damage or general damages caused or in any relating to the use of non issued GPYFA equipment supplied by me at my request. I further represent that I am the parent or guardian of the Minor Child.

I acknowledge that my Minor Child's participation in youth football activities entails both known and unknown risks that could result in SERIOUS INJURY and the use of non issued GPYFA equipment may increase that risk if the equipment is defective or fails to perform as represented by the manufacturer of the equipment supplied by me for my Minor Child's use during the football season

**I therefore expressly and voluntarily release, acquit, and forever discharge GPYFA and agree to hold their respective successors, predecessors and assigns, on its own behalf and on behalf of each and all of its parent, related, affiliated, controlled or subsidiary organizations, and each and all of its respective directors, officers, agents, coaches, attorneys, representatives, volunteers and employees, past, present and future, from any claims, causes of action, suits, debts, damages, judgments, and claims and demands whatsoever, in law or in equity for personal injury, property damage or general damages caused or in any relating to the use of non issued GPYFA equipment.**

I agree that my Minor Child is voluntarily participating in the activities offered by GPYFA and we have elected to utilize our own equipment including football helmet, or shoulder pads, or football pants rather than GPYFA issued equipment. I am therefore assuming on behalf of my Minor Child, all risk of personal injury, or disability to my Minor Child that may result from participation in GPYFA activities while utilizing non GPYFA issued equipment. Further, I have explained these risks to my Minor Child. I certify that I have adequate health insurance to cover any injury or damage that may result from the use of non GPYFA issued equipment, or I agree to personally bear the costs of such injury or damage.

I agree to the sole and exclusive venue of the Snohomish County Superior Court. I further agree that the substantive law of Washington shall apply. I also agree that if any portion of this agreement is found to be void or unenforceable, the remaining portion shall remain in full force and effect.

By signing this document, I intend to forever waive my right and the rights of my Minor Child to maintain any lawsuit or action against GPYFA based on any claim of personal injury or property loss or damage. I have had sufficient opportunity to read and understand this agreement and consult with legal counsel, or have voluntarily waived my right to do so. I knowingly and voluntarily agree to be bound by all terms and conditions set forth herein.
